Notice of Race

Saturday 30th August 2025

1. Rules

- 1.1 Races will be governed by the 'Rules' as defined in the Racing Rules of Sailing (RRS) 2025 – 2028 except as they are changed by the Bowmoor Sailing Club sailing instructions, the prescriptions of the RYA and this Notice of Race.

2. Condition of Entry

- 2.1 The regatta is open to boats of the RS Tera class (Sport and Pro). Eligible boats may enter by completing an online entry form [here](#).
- 2.2 The safety of the boat and its entire management, including insurance shall be the sole responsibility of the competitor racing the boat.
- 2.3 All craft on the club premises (on land and on the water) must have full insurance cover, including third party liability to £3,000,000.
- 2.4 The race organisers shall not be liable for any loss, damage, death or personal injury howsoever caused to the owner/competitor, his skipper or crew, as a result of their taking part in the race or races. Moreover, every owner/competitor warrants the suitability of his boat for the race or races.
- 2.5 To prevent the spread of non-native species boats and trolleys should be cleaned prior to arrival. Check Clean Dry:

- 2.6 The deadline for entering is at midnight on the 23rd August 2025.

3. Organising Authority

- 3.1 The organising authority is Bowmoor Sailing Club.

4. Safety Regulations

- 4.1 All competitors shall wear adequate personal buoyancy at all times whilst afloat. (RRS Section A Rule 40.1 applies)

5. Entry and Registration

- 5.1 There will be an entry fee of £15 per boat.
- 5.2 Eligible boats must enter by completing an online entry form at:

- 5.3 All entrants must hold a current RS Tera class association membership.

6. Event and Programme

- 6.1 [Sailing instructions](#) will be available at entry registration on the day of the event and are posted on the club's notice board in clubhouse. A copy can also be found on the Bowmoor website. (refer to 'Calendar / Open Meeting Calendar' page)
- 6.2 Hot and cold food and drinks will be available, to purchase at the Galley (by Hacketts).
- 6.3 Entry registration will commence from 09:30am Saturday 30th August.
- 6.4 There shall be a briefing for all competitors at 10:30am.
- 6.5 First warning signal shall not be before 11:00am.
- 6.6 The race starting sequence shall be as defined in the Bowmoor 'Sailing Instructions for Open Meetings' available [here](#) on Club noticeboard and as defined at RRS Rule 26.

7. Advertising and Sponsorship

- 7.1 There is no requirement for advertising on boat hulls or sails for this event.

8. The Course

- 8.1 The course shall be available at the briefing.

9. Scoring

- 9.1 Points
The low point scoring system will apply as set out in RRS A4. Boats that did not start, did not finish, retired after finishing or were disqualified shall be scored in accordance with RRS A5.2.
- 9.2 Series Ties
RRS rule A8 applies.

- 9.3 Individual Scoring
Boats will be placed in order of their combined points.
A) When fewer than four races have been completed, a boat's series score will be the total of her race scores.
B) When more than four races have been completed, a boat's series score will be the total of her race scores excluding her worst score.
- 9.4 Races shall be run as "first past the post".
- 9.5 For the Tera fleet, sailors must choose which rig they intend to use at registration on the morning of the event. Sailors must then sail with their chosen rig for the whole event. If there are sufficient entries for each of the different rig types, separate prizes may be awarded.

10. Camping

- 10.1 Caravans and Tents are permitted in the camping field throughout the event, inclusive of the entry fee.

11. RISK STATEMENT

- 11.1 Rule 3 of the Racing Rules of Sailing states: "The responsibility for a boat's decision to participate in a race or to continue racing is hers alone."
- 11.2 Sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor agrees and acknowledges that:
- (a) They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
 - (b) They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
 - (c) They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
 - (d) Their boat is in good order, equipped to sail in the event and they are fit to participate;
 - (e) The provision of a race management team, patrol boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
 - (f) The provision of patrol boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.
