## **Agenda**

Change in covid restrictions implications

John commented that there is considerable evidence of people not following the covid guidelines

At the weekend there were 4 tables with people from 4 households sat within a metre of each other – this is a breach of covid. There is a responsibility on club directors to make sure guidelines are working – by allowing the tables on the decking, directors are in effect responsible for allowing breaches in behaviour

We need to ensure families keep to one family per table. Signs on the glass to reiterate limitations on mixing on tables on decking

Awaiting new govt guidelines tomorrow – arrange meeting on Thursday evening to review implications

Water based activity is likely to be unaffected – but shore-based activity is not so secure. Consider moving tables off the deck. Messaging to be robust on no mixed households and then move tables if still not compliant. Agreed on robust messaging as the stepping stone, with option to remove deck access if no compliance

Membership

Consider boundary areas for membership categories

Sailing / swimming / paddling (SUP and Canoe)

SUP don't meet categories of CASC. But canoe do

Viewed and discussed Tom's diagram – what is target split in sailors / swimmers

Discussed the implications of SUP not being CASC category

But canoe does have the option of CASC or non CASC

Short break and then meeting resumed

Doug has been categorising potential members on waiting list, so it is possible to identify what people's intent is in joining the club

If we set limits on % of each membership category, then that would need to be approved by AGM

Refer to Tom's diagram for agreed category limits. Sailors 60% / swimmers 25% / SUP 15%

Changes need to be approved at AGM

Outline reasons for change – we are sailing club as stated in our articles of operations

Define sailing member – someone who owns or hires a boat

In October we will invite all members to renew and then aim to bring membership within guidelines above over renewal period
